Mission


To promote the use of Gas as a clean fuel and contribute to the clean environment and sustainable development;

To develop Dialogue with all stakeholders, including other producers and consumers.







- Promote exchange of Data and enhance close coordination with GECF Member and Observer Countries.

















Data Quality Visual Check : Monthly Growth Rate






Monthly Growth Rates 2


