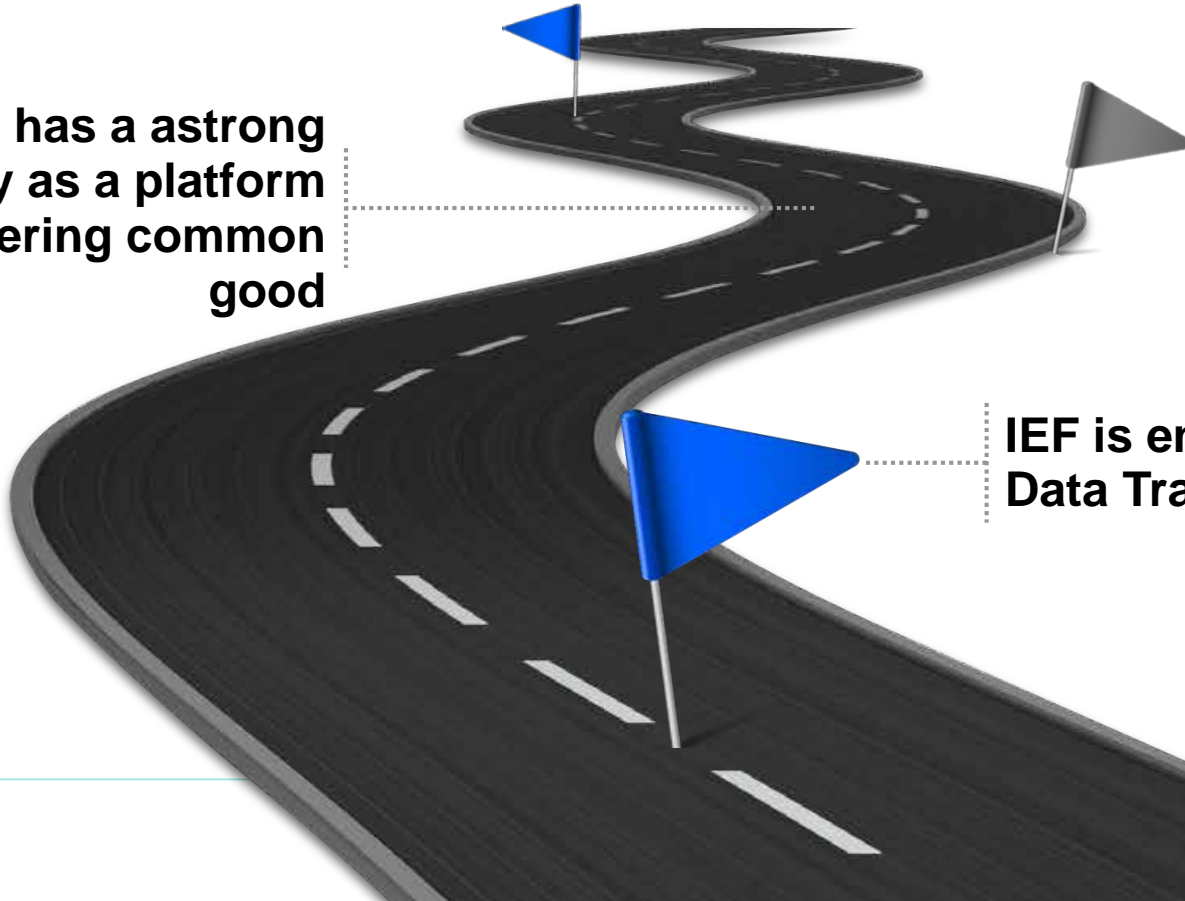

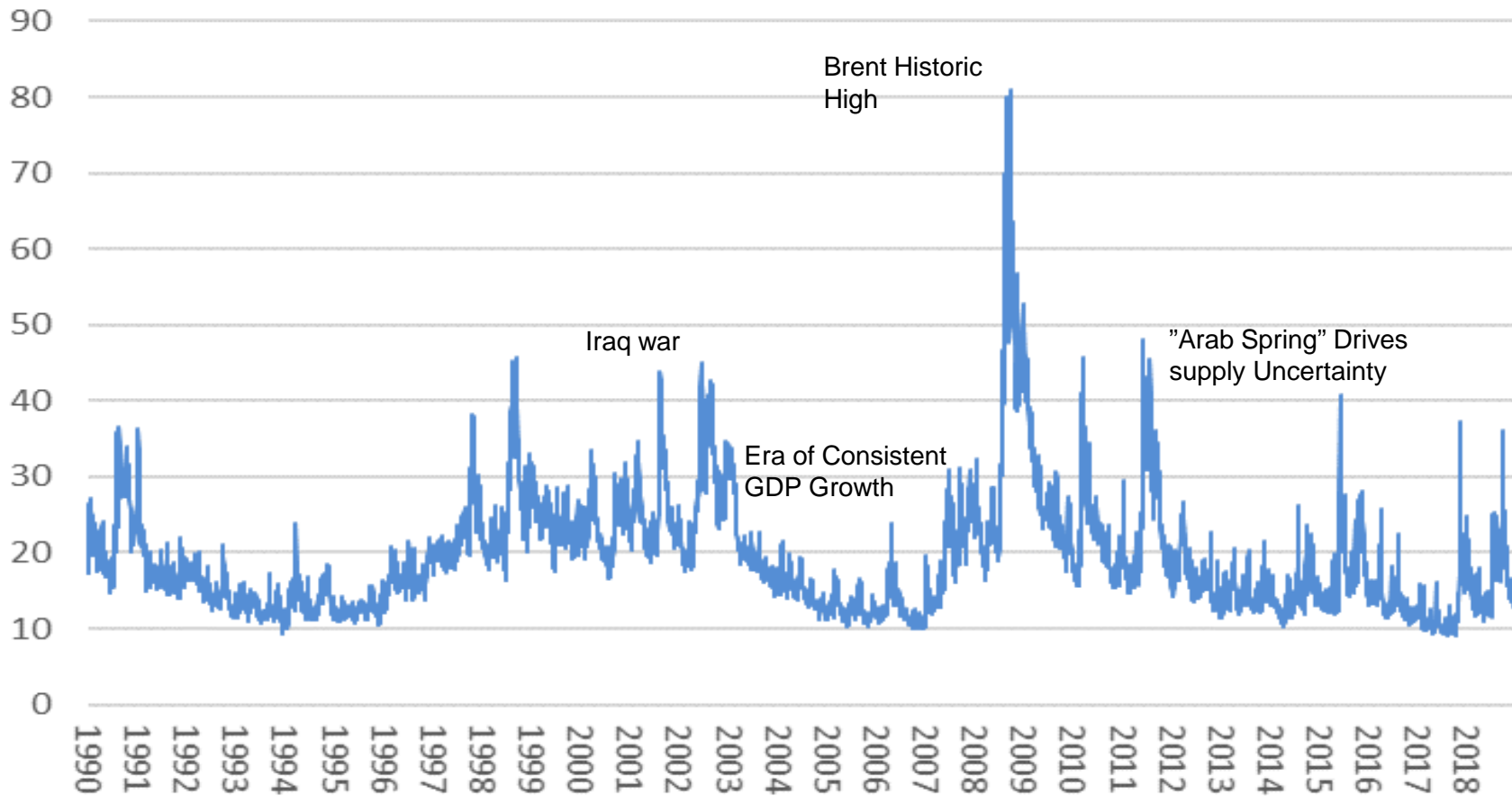

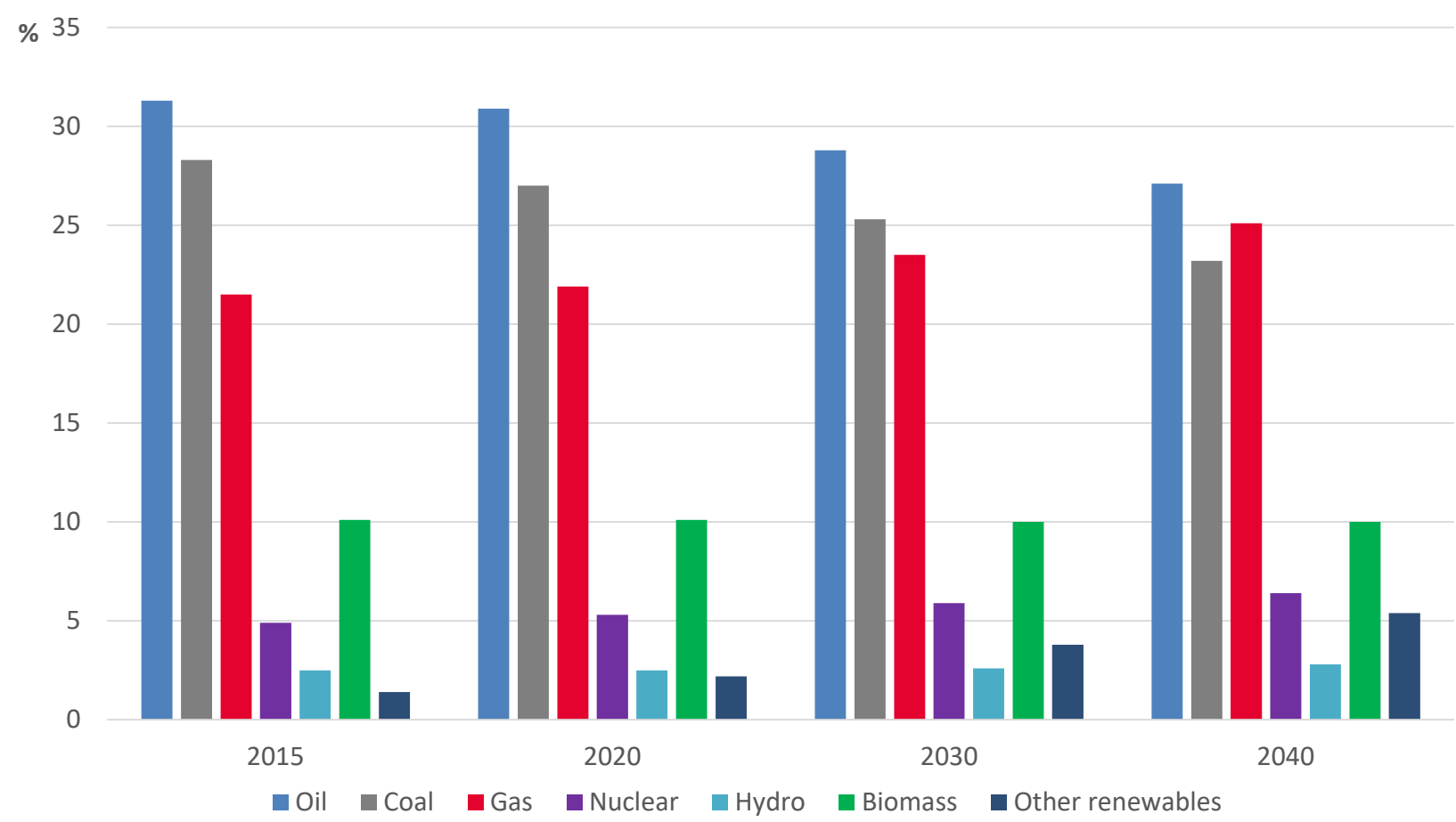

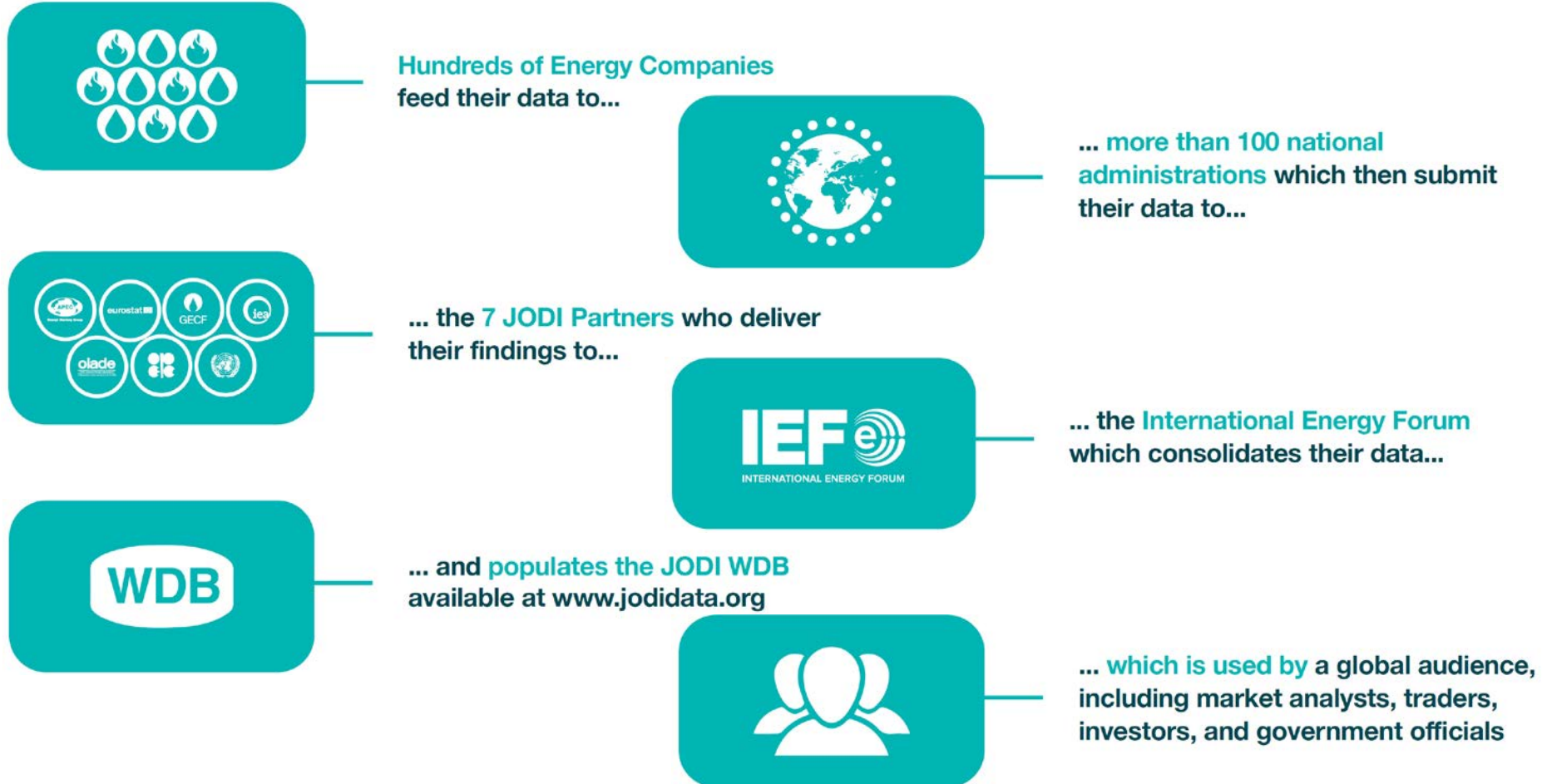

Much progress made since 2000

- 2000: JODI was set up by (APEC/EUROSTAT/IEA/OLADE/OPEC/UNSD)
- 2003: JODI became a permanent initiative
- 2005: The IEF assumed the role of JODI Coordinator
- **2005: JODI-Oil world database (90+ Countries) opened**
- 2009: JODI-Gas “exercise” (52 Countries) initiated
- 2012: Extended JODI-Oil data points released
- 2014: GECF became a JODI Partner
- **2014: JODI-Gas with 75+ Countries launched**
- **2016: JODI Heads Endorsed the JODI 5-Year Plan**
- **2017: JODI Data on Industry Platform (Bloomberg & Reuters)**
- 2018: JODI included OAPEC and AFREC as JODI Associates

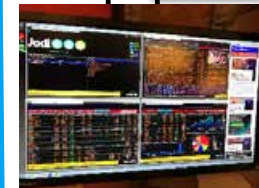
